While OSHA lacks a specific standard for workplace violence, the OSH Act’s General Duty Clause mandates a hazard-free workplace, and OSHA enforces this after incidents of violence. Additionally, OSHA is working on rulemaking for specific industries. California has pioneered a workplace violence rule for general industry, requiring most employers to have a written prevention plan, investigate incidents, maintain logs, conduct annual training, and comply with recordkeeping. This general industry rule follows the California/OSHA regulation on Workplace Violence Prevention in Health Care.</i>
