SCOTT ARMSTRONG Program Manager of the Crew Member Self Defense Training Program (CMSDT

Scott joined the Aviation Programs Branch (APB) in February 2016 as the Program Manager of the Crew Member Self Defense Training Program (CMSDT) Scott coordinates and manages all CMSD training at the Federal Air Marshal field offices around the country. Additionally, Scott manages and directs CMSD training at airline training centers where he has established Memorandums of Understanding (MOUs) between TSA and the designated airlines. Scott also assists with the Quality Assessments of the Federal Flight Deck Officers recurrent range training as required.

Prior to joining APB, Scott was the senior training instructor at the Washington Field Office for nearly 14 years, where he supervised and conducted all aspects of FAM training for Air Marshals assigned to the office. Scott also maintained liaison with multiple federal, state, and local law enforcement agencies requiring Flying While Armed training as well as the Law Enforcement In-Flight Tactical Familiarization Course. Scott managed the Armed Security Officer training for all assigned ASOs where he scheduled and conducted training classes and semi-annual firearms requalification as needed. Dr. Kuntz has worked in workplace drug testing for the past 35 years and has testified extensively regarding drug use, interpretation, and adulteration of urine, hair, oral fluid and sweat samples using GC/MS and LC-MS/MS. The primary research focus of the last 15 years has been in the development of testing panels for designer drugs, CBD, THC, and THC metabolites in urine, blood, and oral fluids.

Dr. Kuntz is an inspector for the SAMHSA and CAP forensic drug testing programs and a past member of the national Drug Testing Advisory Board, NLCP MSMS Standards Working Group, SAMHSA MRO Manual for Urine/Oral Fluid Working Group, and editorial board for Clinical & Forensic Toxicology News.
